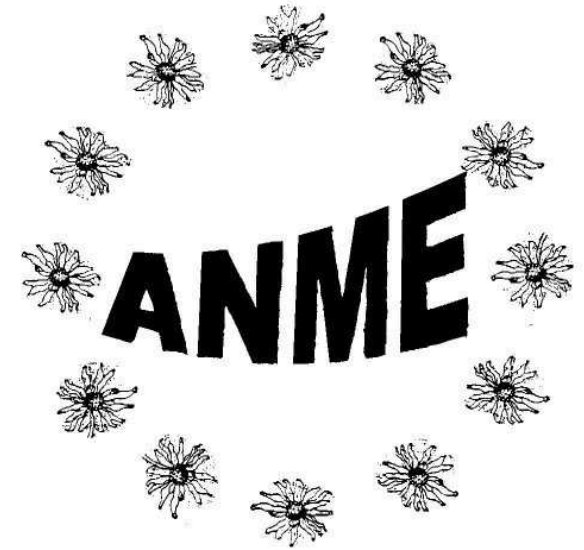

- to establish and enlarge a European-wide network that grants the coordination and safeguarding of common naturopathic interests in European policies.



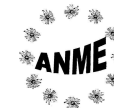
ANME :
